Sales and Usage Tax

Prom Nite is required by law to collect sales tax on orders shipped to applicable states. Minnesota—MN residents in Anoka, Dakota, Ramsey and Washington counties, add 7.125% sales tax. MN residents in Hennepin county, add 7.275%. All other MN residents, add 6.875% sales tax. If tax exempt, provide a copy of tax exempt certificate.

Colorado—CO residents in Colorado Springs, add 7.63% sales tax. CO residents in El Paso county, add 5.3% sales tax. All other CO residents, add 2.9% sales tax. If tax exempt, provide a copy of tax exempt certificate.
